AST services include the inspection, repair, removal and new construction of aboveground tanks. Services provided includes routine maintenance projects, repairs and replacements required due to corrosion, deterioration, or damage, as well as spill prevention, containment and countermeasure (SPCC) actions. TTI offers the latest in NDE equipment for Aboveground Storage Tank inspections, spheres, and piping by fully qualified API 653, 570, 510 and ASNT certified inspectors.

Removal / Install - Municipality

TTI was contracted to removed five (5) 4,000 gallon USTs, installed two (2) 4,000 and two (2) 6,000 ASTs with all ancillary equipment, site preparation, asphalt, concrete and necessary soil remediation.

Install - Federal

TTI was awarded a prime contract for the Department of Veterans Affairs, Montrose, NY. TTI crews removed eight (8) USTs, repaired eight (8) and installed three (3) 30,000 gallon and one (1) 1,000 gallon AST.

All services are conducted by certified API 653/570/510, AWS-CWI, ASNT and ASME inspectors. TTI utilizes the latest NDE equipment to perform Magnetic Flux Leakage (MFL) floor scans, ultrasonic thickness surveys, magnetic particle examinations, vacuum box testing, remote visual inspection robotics and more to assure reliable and safe operations.

API 653 Inspections – Federal / Engineering

TTI provided AST inspections for the USACE Omaha District and AFCEC under a contract with a large engineer, inspecting 1152 tanks at 41 Air Force Bases nationwide. TTI was contracted by the Air Force to film and produce a tank handler instruction DVD to be used at all installations.

API 570 Piping Inspections – Federal / Engineering
